

Tiny Tots - Privacy Policy

1. INFORMATION WE COLLECT

Legal Requirements: We may disclose your information if required to do so by law or in the good faith belief that such action is necessary to comply with a legal obligation, protect and defend our rights or property, protect the personal safety of users of the Site or the public, or protect against legal liability.

We take reasonable measures, including administrative, technical, and physical safeguards, to protect your information from loss, theft, misuse, unauthorized access, disclosure, alteration, and destruction. However, the internet is not 100% secure, and we cannot ensure or warrant the security of any information you provide to us.

Our services are not directed to children, and we do not knowingly collect personal information from children under the age of 13.
